**STRUCTURED MEETING BETWEEN CIRCLE MANAGEMENT AND
REPRESENTATIVES OF SBI PENSIONERS ASSOCIATION (KARNATAKA)
HELD ON 03/09/2025.**

AGENDA

- 1) Structured Meetings to be held once in six months not being held regularly.
- 2) Structured Meetings also to be held between Pensioners Association representatives and AO Management at all the AO offices once in 6 months which is not being held.
- 3) Office space along with required infrastructure to be provided to the Pensioners Association at all the AO Offices and bigger space for office at LHO Campus.
- 4) A new office space to be provided to the FEDERATION OF SBI PENSIONERS ASSOCIATION since the Head Quarters to be shifted shortly from Kolkata to Bangalore.
- 5) Payment of Stagnation increments arrears to pensioners who are under - 10th 11th and 12th Bipartite if any.
- 6) Refixation of New Pension basic to pensioners who are under 10th 11th and 12th Bipartite Settlements and Updation of the same in Pension Payment Advice.
- 7) Fresh PPA to be issued to all the Pensioners with the new pension Basic mentioned therein.
- 8) All the Family Pensioners to be paid Pension at the rate of 30% as per Banks E Circular and fresh corrected PPA to be issued without further delay.
- 9) Proper instructions to Branches to receive application from retirees on account of stagnations increments, Fresh Family Pension Applications, Applications for issue of ID card and the same to be sent to Sanctioning authorities without delay and follow up.

MEDICAL FACILITIES TO PENSIONERS AND FAMILY PENSIONERS.

- 1) Establishment of Dispensaries at all AO Centres/RBOs located in other places and particularly Bangalore South which has been closed due to reasons not known to us.
- 2) Posting of permanent Doctors at all AO Centres along with qualified pharmacists and hiring doctors at other dispensaries wherever located with qualified pharmacist.
- 3) Providing of Insulin pen to pensioners and Family pensioners as many of the pensioners aged above 65 are not able to administrate insulin injection by themselves. In case of highly aged pensioner above 70 they may be permitted to purchase from outside and reimburse the amount, as was done during Pandemic times. Medicines from Banks Dispensary to be sent to pensioners residence through courier especially to those above 75 years and handicapped pensioners and consultation with Bank Doctors over telephone.
- 4) Holding of Medical Camps in different centers for the benefit of Pensioners and Family Pensioners.
- 5) Holding of regular meetings with Pensioners Association Representatives and the Brokers, TPA's in the presence of HR official.
- 6) Problems relating to settlement of claims to be discussed with Pensioners Association for early disposal. Representatives of TPA/INSURANCE BROKERS may be asked to furnish the reasons there. Unpaid/ Rejected Bills should be returned back to the pensioners under advice to SBIPA(K).

With the Bank introducing the SBI Tribute Scheme we thank and welcome the gesture from our Bank with a request to inform ONLY OUR Pensioner Association and allow representative of our Association to accompany with the Bank Officials to the residence of the deceased pensioner/retiree as mentioned in the circular.

The Circle Management responded positively to all the above issues raised by the Association.

ELECTION TO SBIPA(K) 2025 - 2028, RULES / GUIDELINES

1. All new Members of SBIPA(K) enrolled on or after 01-01-2022 are eligible to vote/contest in the Elections to SBIPA(K) for the term 2025-2028.
2. Such of those Members who are enrolled to SBIPA(K) before 01-01-2022 to pay their arrears of subscription up to the year 2022 to become eligible to vote/contest in the election to SBIPA(K) for the term 2025-2028.
3. Election will be held in Bangalore on the date of Annual General Body Meeting Election Committee consists of:
Chief Returning Officer - 1, Returning officer -1
Polling officers - As decided by Returning officers
4. All the new members enrolled to SBIPA(K) on or after 01-11-2025 till the date of election are not eligible to vote.
5. Election time is between 9.00 a.m. and 1.00 p.m.
6. Elections in Bangalore city will be held at Sri Chandrashekhar Bharathi Kalyana Mantapa between 9.00 am and 1.00 pm on 24-11-2025.
7. Any Member who desires to pay arrears of subscription as notified /called for by the Association may be allowed to do so on the day of election.
8. **Contesting for different post/s will be in the specified nomination form duly filled/signed by the Contestant with his /her Membership No. of SBIPA(K). It should be proposed and seconded by two different members of SBIPA(K). However any one of the three i.e. contesting candidate or proposer or seconder is found classified under Byelaw No.25 (A) nomination becomes invalid.**
9. After the polling, counting will be done at the place of General Body Meeting.
10. The results will be officially announced at AGM as part of Agenda.
11. In case of elections to be held for multiple posts, separate ballot papers with different colours will be printed.
12. Nomination Forms are available in September 2025 Musings and also available at Association Office from 25-09-2025 on all working days between 11.00 a.m and 4.30 p.m.
13. All the decisions/directions will be mutually discussed between General Secretary SBIPA(K) and Election Committee. Decision of the Election Committee will be the final.

PROVISIONS IN BYE LAW FOR CONDUCTING ELECTIONS

No.17: Elections to the posts of the Office Bearers shall be held once in 3 years at the ordinary Annual Meetings of the General Body.

No.18: The Managing Committee shall appoint one of the members of the Association who declares in writing that he has no intention to contest in the elections, as the Returning Officer to conduct the elections.

No.19: The Managing Committee shall draw up a schedule of elections and then Returning Officer shall issue a notification calling upon the members to elect the office bearers. After the Returning Officer issues the notification the Managing Committee shall have no power to alter the schedule of elections.

No.20: After conclusion of the elections, the Returning Officer shall make a report to the General Body and declare the results in the meeting of the General Body.

No.21: The Managing Committee shall have the powers to make rules for the conduct of the elections. All rules made by the Managing committee shall be placed before the General Body for information and record.

ELECTIONS TO BE HELD FOR THE FOLLOWING POSTS TO SBIPA(K) FOR THE TERM 2025-2028 AS PER RULES AND REGULATION OF THE ASSOCIATION BEARING NO. 11A,12,13,14 & 15.

No.11A:He/She shall pay the annual subscription or any other amount payable to the Association as per the decision of the Managing Committee or General body from time to time. Failure to pay the dues will attract penalty of cessation of membership (for a continuous period of three years).

Every Member of the Association shall have the right;

- a. To offer himself for election to the Managing Committee and to propose / or to second the nomination of a candidate for election to the Managing Committee.
- b. To vote at any General Body Meeting (voting shall be conducted either by secret ballot or by show of hands.)

No.12: The Managing Committee of the Association shall consist of the following Office Bearers.

1. PRESIDENT	- 1 (ONE) POST
2. VICE PRESIDENTS	- 4 (FOUR) POSTS
3. GENERAL SECRETARY	- 1 (ONE) POST
4. JOINT GENERAL SECRETARY	- 1 (ONE) POST
5. SECRETARIES	- 9 (NINE) POSTS
6. TREASURER	- 1 (ONE) POST
7. ASSISTANT TREASURER	- 1 (ONE) POST
8. COMMITTEE MEMBERS	- 8 (EIGHT) POSTS

Of the Nine posts of Secretary one post is for Hubballi and one for Women Pensioners shall be reserved.

No.13: Of the Eight posts of Members of the Committee, one post shall be reserved for the Women Pensioner member and one for the Family Pensioner member.

No.14: Only members who are permanently stationed within Bangalore Metropolitan area shall be eligible to contest for the posts of the Office Bearers, except that for the reserved post of the Secretary for Hubballi Zone, members stationed permanently within Hubballi-Dharwad Corporation area shall be eligible to contest.

No.15: Only Women Pensioners and only Family Pensioner members shall be eligible to contest for the posts reserved respectively for them.

2. Additionally, the meeting discussed issues such as the non-application of DA merger @8088 points to past retirees and improvements in the Mediclaim Policies, E-pharmacy, etc. The debate was meaningful and purposeful, giving a focused agenda for the following term.

4.
