SBI HEALTH ASSIST

Much awaited, circular on SBI Health Assist policy 'B' and SBI Health care - policy 'A' has been issued by the Corporate centre vide circular No. CDO/PHRD-PPFG/60-2022-23 dated 7th January 2023. SBI General Insurance Co. Ltd., has been selected for serving both the policies for the next three years. The policy was due for renewal from 16-01-2023.

According to this circular, existing members under SBI Health Assist for policy year 2022-23 would be eligible to renew the policy till 15th January, 2023 by paying annual premium.

Employees who retired on or after 17th October till 15th January 2023 and who have not taken membership of SBI Health, Assist 2022-23 would be eligible to join the policy till 15th January 2023, by paying annual premium.

Along with the above provisions, other few pensioners also were provided for the spouses of deceased employees, new retirees retired on or after 16.1.2023, and e-AB retirees to join the policy till 15th January 2023.

Other details of the policy can be had from the above circular.

The procedure for Renewal/Enrolment for SBI Health Assist policy (B) for pensioners / family pensioners was laid down in the circular. For other features of SBI Health care, please go through the Annexure-V of the circular.

Renewal to be made through online Application in HRMS and requirement of submission of physical declaration is dispensed with.

With instruction to submit renewal applications in HRMS, many of our members finding it difficult and struggling hard to submit within a period of 5 days as they are having lack of knowledge of HRMS/ technology / computerisation etc., panic situation was created. At this stage Pensioners Associations and the Federation had to intervene. They requested the corporate office/respective local Head offices to sort out the problems immediately. Because of this Management agreed to accept the renewal applications both manually and through HRMS online inspite of two holidays on 14th and 15th January 2023 they allowed few Branches to function normally to accept the renewal applications. Besides SBI pensioners Association (Karnataka) was kept open on all days from 9th January to 14th January 2023 and helped the members. Our units of other District centres also helped to a maximum extent and provided necessary assistance to the members. This was well appreciated by the members. We are thankful for all our Committee Members for their timely assistance in this regard.

At the request of Pensioners Federation the last day of submitting for renewal of policy (B) has been extended Upto 31st January 2023. This will definitely help our members who were not able to submit the applications earlier to submit new.

In this connection, we are of the opinion. that it is right time for all SBI Pensioners to guide all other friends who have not registered on HRMS Portal to do so. In future HRMS SBI, becomes important for every thing as long as we are pensioners.

DEMISE OF SHRI HANUMANTHRAO JUJURE

This is the incident involving Cashless claim under SBI General Health Insurance B Scheme.

Mr. Hanumanthrao Jujure, ex-SBI Official who predominantly worked in Belgaum area migrated to Our Nobel Residency Colony, Banneghatta Road, Bangalore 6 months ago. In our natural discussions, he renewed the Policy B by remitting Rs.25,000+ soon on opening of the scheme last week. He had paid the amount through his pension Branch (Rajajinagar) on 11.01.2022 for a total coverage of Rs.20.00 lakh.

On the evening of 16th January 2023, Hanumanthrao collapsed on the road while taking a stroll near his house along with his wife. Immediately passerby shifted the injured in an auto to nearby Nobel Hospital. With preliminary tests, treatment, Hospital found that Hanumanthrao suffered a massive heart attack. As advised by attending Doctor, he was shifted to Fortis in an ambulance at 7.45PM.

Mrs.Hanumnthrao, could not carry any of the papers such as ID,Insurance card etc for admission purposes at Fortis. Hence, the Hospital authorities demanded Cash deposit of min. Rs.1 lakh before emergency treatment. Some how could make the payment, and the treatment started. It is learnt that 3 blocks were there and stunts were implanted. However, Hanumntharo died at 10.15 PM, due to low BP and could not survive. His son (studying at Mumbai) joined us at midnight.

Next day (17th January 23), the Cashless insurance claim was submitted with all the necessary papers. However, TPA at Hospital could finalise the Claim Bill only at 4.30PM and forwarded it to SBI General through Anand Rati. At about 9.30PM, we came to know that the claim was rejected as "policy lapsed on 15th Jan.2023". Hospital insisted renewal card if policy was renewed to persue the claim. On enquiry by the Son of Hanumanthrao, whether cash can be paid, and what was the claim amount. Hospital told him to remit cash of Rs.5.50 lakh. He was totally disturbed in not understanding as to why such huge

difference. He wanted to know further course of action. Then Shri. Sridhar, insurance representative at A.O. was approached. He said that the Policy is same and is continued (no question of lapse of Policy as the payment was made before commencement of renewal). He gave the e mail id as under and also that he would follow up so the claim is settled before 10.30 PM.

He advised them to request Hospital and also Sachin (S/o. Hanumanthrao) to mail with the proof of renewal payment receipt. Once this was done, to our surprise, the claim was settled for full claim of Rs.3.25 lakh. Later, the body was released and shifted to the residence of Hanumanthrao for further rituals. We pray for enough courage for the family in this situation.

This is the sincere and swift action taken by Shri Sridhar.

This is to bring to the notice of our colleagues/their family will be in a better situation than the family of Hanumathrao was placed.

- i) Mrs. Hanumathrao did not have any bank account (either Jointly or singly) and hence did not have access to emergency funds. Son stays at Mumbai and Daughter stays at US.
- ii) It is better to have SB account with some balance with UPI (i.e.Phone pay/Google pay etc.) as now everybody carries mobile to all places. We can pay through UPI Rs.1 lakh max. per day.
- iii) Renewal of Policy should be done as early as possible as "nothing is certain".
- iv) Keep close contact with Sridhar who is a nice and helpful person for such situations.
- v) Preserve the e-mail IDs given above.

Minutes of the Meeting

2. A minute's silence was observed in memory of those pensioners who left us for eternal abode.
3. 33 pensioners aged 70/80 years of age including 9 of them with spouse were honoured by the chief guests. Shri B Ravindra Pai was the M.O at the honouring ceremony.
4. The D.G.M, Shri J O B JOSE in his address lauded the Pensioners' Association for holding the meet and honouring the senior pensioners aged 70/80 years. He assured the pensioners that he would endeavour for redressal of grievances of the pensioners within his powers. 10. Shri K K Poojary, President of Mangalore unit spoke on the occasion. He stressed the need of having an oldage home in Mangalore for Bank pensioners. He explained the salient features of the proposed old_age home and sought suggestions and co-operation of the members.
11. S/Shri B Ravindra Pai and Jayaprakash, pensioners-members of Mangalore unit with their strenuous efforts made the Pensioners' Meet a grand success.
12. Sri Naga Subba Reddy the Chief Manager of Mangalore Branch made all the arrangements including snacks for the Pensioners' Meet.
13. The meeting concluded with a vote of thanks by Shri K Vishwanath, Secretary of the Mangalore unit.
